The land and premises being acquired by this order must be vacated and possession given up to the State Transportation Board on the date of filing of this order with the Town Clerk of the Town in which said land and premises are located. Improved properties must be vacated within 90 days of written notice of this order.

Any owner or interested person, affected by this order, who is dissatisfied with the amount of damages awarded by the State Transportation Board as set forth in this order may, within ninety days after the date this order is filed with the Town Clerk, institue an appeal by a Petition in writing to the Chittenden Superior Court and will be entitled to a hearing or a trial by jury if desired.

For further information of premises and rights acquired by this order reference is hereby made to plans of Highway Project Williston-Colchester PB 033-1(1) as filed in the office of the Clerk of the Town of Essex or any revisions thereto subsequently filed therein.
